Subj: COMMUNICATION PROCEDURES

- 1. <u>Purpose</u>. This letter provides guidance and policy concerning communication between Members and Directors of the Board.
- 2. <u>Policy</u>. Reference (a) establishes the policy for the Cleburne Soccer Association.
  - a. Members that wish to communicate with the Board of Directors concerning their player or team shall observe the following chain of command:
    - (1) Coach the coach is the starting point of all conversations regarding the player.
    - (2) Age Group Commissioner If the problem cannot be resolved with the coach or the coach is the matter of discussion, then the member can then contact the Age Group Commissioner.
    - (3) Registrar Only age group commissioners need to communicate with the registrar concerning the movement and disposition of players. The registrar can communicate with members if more information is needed.
    - (4) Vice-President Only Directors of the Board need to communicate with the Vice-President on matters related to the Appeals & Disciplinary Committee
    - (5) President Members desiring to bring a written grievance against any member of the Board of Directors in accordance with (IAW) 4.3 of Reference (a).
  - b. Email is the preferred method of communication. The Secretary and Registrar will monitor the main association email account and distribute, as needed, emails to Directors of the Board.
  - c. Postal Mail shall be retrieved by the Secretary and distributed, as needed, to Directors of the Board IAW 2.7.8 of Reference (a).

- d. In person contacts at practice, games, or other CSA functions may be immediately handled if necessary by any Director of the Board. Follow up, as needed, shall be communicated with the appropriate age group commissioner or other Director of the Board pertinent to the situation.
- e. Members that fail to follow the establish Chain of Command shall be redirected to the appropriate person to handle their concern unless the concern is of a general nature and requires no further action beyond the actual conversation itself.
- f. Directors of the Board are not authorized to speak on behalf of the association to any organization without prior permission from the President. This includes, but is not limited to the City of Cleburne, North Texas State Soccer Association, and Metroplex Soccer Alliance.
- g. Directors of the Board shall support the decisions made by the Board of Directors in any contact with association members. Failure to do so undermines the position of the board, the support of the other members, the direction of the KSA program, and puts in jeopardy the value that these volunteers provide to the players, parents and spectators alike.
- h. Any contact with any association member (phone, e-mail, inperson, etc.) considered verbally or physically insulting, threatening, or abusive will be considered for disciplinary actions through an association A&D hearing by the A&D Chairman and nominated committee. The necessary punishment shall be deemed by the decision of the A&D Committee.
